4.1 25/01746/PA Royal British Legion Industries, Hall Road, Aylesford South

Details of Conditions 24 (Archaeological investigation), 31 (Surface water drainage) and 36 (Surface water drainage) submitted pursuant to planning permission TM/25/00382/PA (Demolition of existing building and structures to provide 1no. warehouse building within a flexible B2 / B8 Use Class (General Industrial / Storage and Distribution), together with open storage (Use Class B8), alongside associated landscaping, parking and servicing and other infrastructure)

5. Blue Bell Hill – Temporary Accommodation Project

- The 'pods' have a life expectancy of about 100 years
- The term 'Temporary' refers to people staying in them temporary not the pods being placed there temporarily
- They are most definitely not for migrants

- There will be a Warden on site, so there is someone residents go to if they have and concerns or issues this is something that should be made public knowledge as it a massive reassurance for residents.
- Their tenancy agreements will be open not fixed terms, so they can be asked to leave at any time.
